Parties should lift the material from our factory on **as is where is basis**. When you bring trucks, you have to come with the workmen for shifting the materials and loading the truck manually. All workmen shall have insurance coverage under Workmen Compensation Act or ESI/PF Coverage. All the statutory requirements as below should be available when you bring vehicle for loading scrap items at our plant. Vehicles without valid documents as below will not be allowed inside our premises and scraps shall not be loaded to such vehicles which are not complying the requirement. **RC / FC / Insurance / Driving Licence / Emission Certificates etc and all other statutory requirements as applicable for the vehicle, driver and cleaner if any.**

It is in the scope of the successful contractor to process and weigh the materials as per item no. 6 of in presence of BL representative before loading the same

The available materials may be inspected on any working day between 10:00 AM to 4:30 PM. Contact Person: Mr. Gopi- (044)25946574. Your offer shall be for all the items. If the tenderer is not quoting for all the items, their offer will be disqualified.
